

- **Nathalia Artus** - VP Director of Community Development, Atlantic Union Bank. Nathalia's focus at work is promoting community economic development through financial assistance – including within the nonprofit and governmental sectors. She is active in the support of Richmond's nonprofit community and currently also serves on the Boards of Family Lifeline and Virginia Supportive Housing.
- **Jane Ferrara** – Executive Director, Local Initiatives Support Coalition (LISC) Virginia. Jane leads LISC Virginia's efforts to raise capital, create innovative programs, and provide policy support to advance a broadly shared prosperity across Central Virginia. Prior to joining LISC Virginia, Jane served as the city of Richmond's senior deputy director for economic development.
